Subject/Letter of partnership between Ministry of Agriculture and Forestry and UNDP in the Implementation of the GCF Project

This to confirm the commitment of the Government of Sudan, represented by the Federal Ministry of Agriculture and Forestry for availing resources of the Government integrated solution project amounting up to US\$ 15 million in support of the implementation of UNDP ADAPTATION PROJECT "Building Resilience in the Face of Climate change within the Traditional Rain-fed Agriculture and pastoral systems in Sudan" submitted to the kind consideration of the green climate fund (GCF). These parallel resources are delivered directly through the Ministries in the states in support of Integrated Solutions Project.

We acknowledge the strong interlinkages built in both programmes, as the Ministry's programme on integrated solutions in Agricultural sector, aimed at improving food security and livelihood for rural households in 18 states through: introduction of improved soil, water and crop management practices, initiate efficient inputs and services delivery system and organize farming communities by formulating producers societies in selected villages through activation of the 2011 Act producers' law. The GCF, UNDP proposed project will be implemented across 10 of these states aiming at the same objectives.
